DETAILS

Tremproof 6100 Membrane is hot applied rubberized asphalt specially formulated from asphalts, rubber and inert fillers. The minimum thickness of the installed products is 180 mil.

The approval is subject to the following conditions:

- 1. Installation of the product shall be in accordance with the manufacturer's instructions and the requirements herein. A copy of this report and the installation instructions shall be provided at each job site by the manufacturer.
- 2. The product shall be used in well ventilated area.
- 3. Adjoining sheet edges shall overlap a minimum of 3".
- 4. All concrete surfaces shall be primed with Tremco Hot Rubber Primer at a rate of 300 to 500 square feet per gallon.
- 5. During construction, the membrane shall be covered by a dark color protective barrier where it is exposed to sunlight.
